

#### Exhibit Setup/Teardown and Display Times:

Exhibitor move-in is the morning of Thursday, April 11 at 8am to Noon. Display times are Thursday, April 11 from Noon to 5pm and Friday, April 12 from

7:30am to 4pm. Please note, all times are subject to change until the agenda for the meeting is finalized and posted on the website. Exhibits can be packed up after the last *Visit-the-Exhibit* session and the exhibitor drawing is at approximately 4pm on Friday, April 12.

## **Booth Assignments:**

The number of exhibits is limited by available space at the hotel. Space is reserved on a first-come, first-served basis. <u>Please note, per ACCME</u> guidelines, booths are not located in the same room as the CME sessions. KAOM prides itself on offering excellent physician contact. There are no bad booth locations.

## Scientific Exhibit Fees & Refunds:
